- MESSAGE FROM THE BOARD PRESIDENT, CYNTHIA EDWARDS -

It was another year of uncertainty and challenge for all of us on many fronts, yet our Unit remained strong, capable and committed, and expanded its support from the community.

Our Victim Services Program is in Flux

September 2020 saw us still awaiting detailed information from Alberta Justice and Solicitor General (JSG) regarding the allocation of the majority of the huge surplus (at least \$50 million) in the Victims of Crime Fund, caused by years of unexplained and undeclared cutbacks. An announcement earlier in 2019 allocated a small portion of the surplus (\$4 million) to increase funding to police-based victim services in Alberta's major cities.

The status of funding for rural police-based units was to be announced but was superseded by the announcement of yet another victim services review undertaken by a new provincial government. That review has been completed, we're told, but the results have yet to be announced or communicated to us. The government continues to speak strongly and often of its support for victims of rural crime; one encouraging sign is that our JSG grant funding has been extended (although not increased) to March 31, 2023. But at this point we're still guessing at what the final operational picture will look like for Victim Services.

We Adapted to the Reality of COVID-19

The ubiquitous coronavirus had a major impact on our Unit. It affected our way of operating, our membership and our revenue. Yet thanks to the terrific support of our staff and our volunteer Advocates, we adapted our operations and continued to provide client services throughout the year.

A Special Thank You

A special thank-you to all members of our team, who despite the challenges and hardships faced over the last year, have shown their dedication and commitment within our organization.

My deep condolences to any of you who suffered personal loss due to this virus.

We were unable to carry out our two annual fundraiser Charity Check Stops in December of 2020. However, we began receiving annual per capita funding from the Town of Blackfalds and secured other sponsorships. These funds have helped compensate for the temporary loss of our major fundraising events and have strengthen our financial position. We're very grateful for this vital support from our community!

In spite of the uncertainty and challenge, we were blessed with significant strengths: dedicated and talented staff who responded with resolve and adaptability to the challenges of working during this tumultuous time, committed and flexible volunteer Advocates, and a strong board. In 2020-21 we offered exemplary service to our clients, we strengthened and supported each other, and we once again exemplified our motto of **Onward and Upward!**

I continue to be inspired by the volunteers and staff of Central Alberta Victim & Witness Support Society, who are the very heart of Victim Services.

They bring their passion and commitment to the residents of the communities we serve each and every day providing trauma informed care. This team responds by helping clients cope and recover after experiencing crime and tragedy.

Whether it's the provision of extra safety measures, access to counseling and treatment, supporting families as they cope with the aftermath of the loss of a loved one or walking alongside a victim through the difficult criminal justice system, this team responded to over 60 requests for service monthly. That equals 1226 new clients served in addition to clients ongoing from the prior year(s).

This, in spite of the ongoing Covid-19 challenges and restrictions, from being "locked down" to "open for the summer" the staff and crisis advocates continued to give it their all!

Once again Domestic/Family Violence files were the highest file type. We saw a substantial increase in trials, preliminary hearings and sentencing.

The future of victim serving programs in Alberta is unknown with continued financial uncertainties in government funding. It's been a year of uncertainty that was weathered by staff and volunteers with confidence and flexibility. Our hope is to see sustainable, focused funding for this vital service to continue.

I wish to extend my sincere appreciation to the Board of Directors, volunteer advocates, family and

friends of VSU, for your valuable contributions and for helping to make a positive difference in so many lives. I also gratefully acknowledge our grant funders and other financial supporters who have contributed to "The Road Ahead Campaign".

In closing, after 15 years with CAVWSS, I will be leaving to begin the next chapter in my life. This time with victim services has gone by quickly. It has been busy and very rewarding! The immense knowledge gained over the years, the valued friendships made, and the memories – too many to count!

I wish CAVWSS the very best to carry on this amazing program with the same passion to serve our clients well. It's been a true honour to be of service.

With the help and support of each other and the extended community, we will continue to make a difference for people when they most need it.

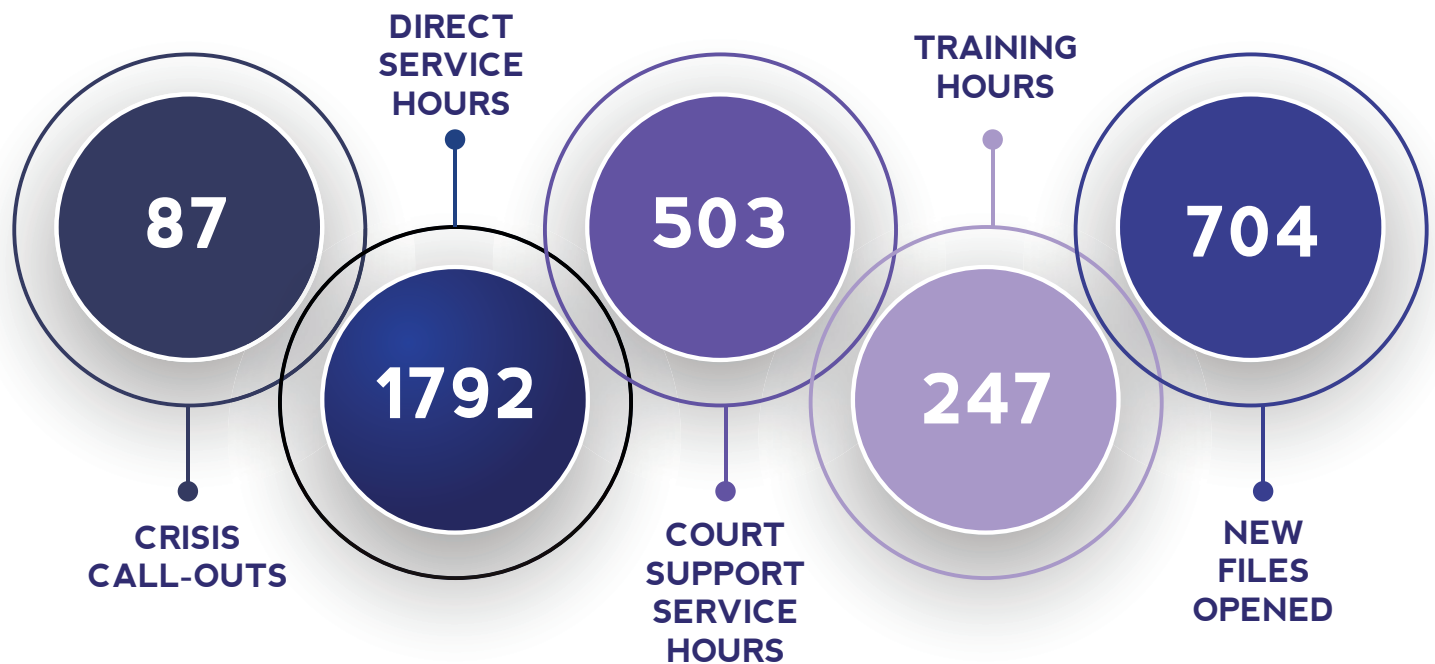
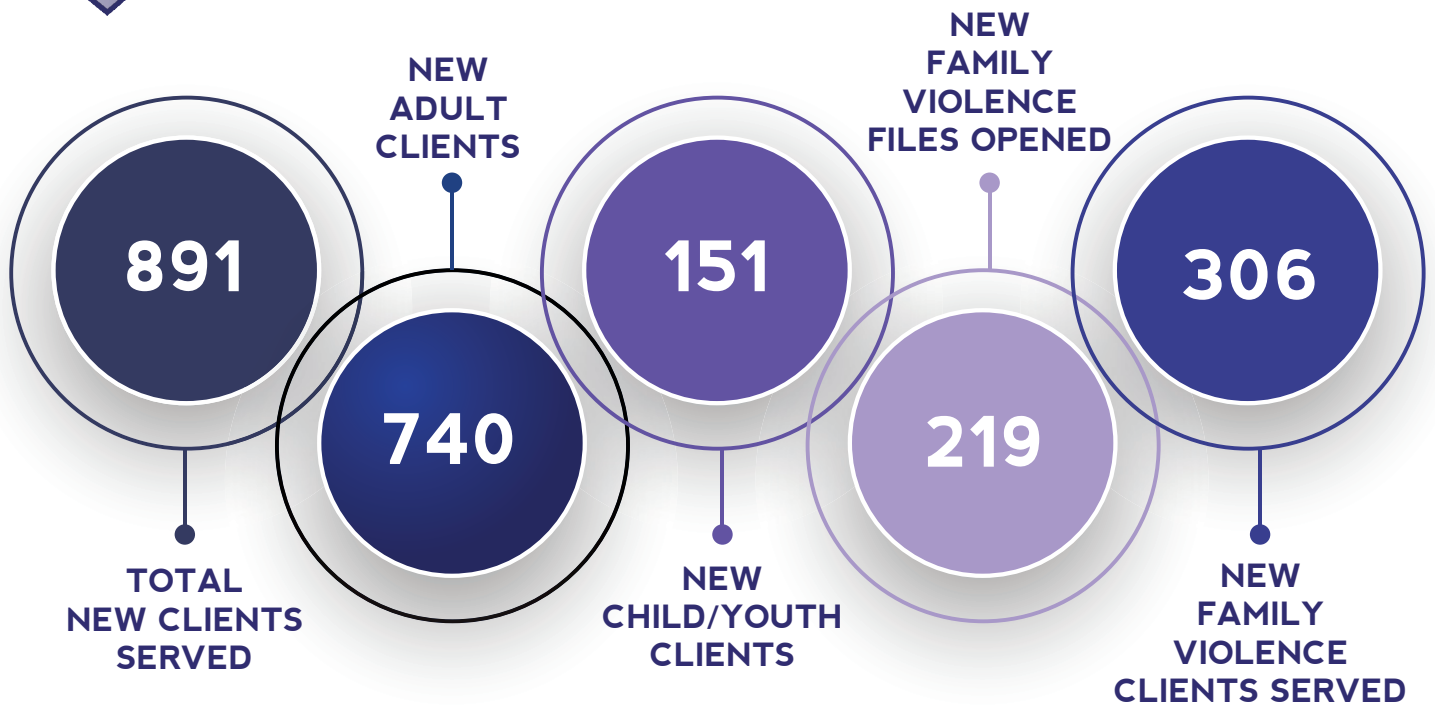
Our mission is to equip clients to engage positively and productively in their community through our professional and compassionate provision of direct support, information, referral and education.

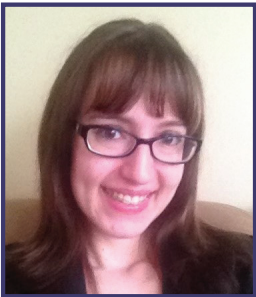

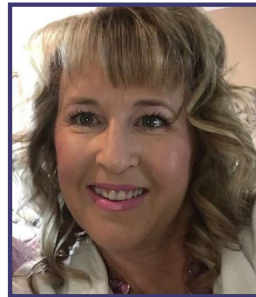
